# First in New Jersey to Earn The Joint Commission's Level IV **Maternal Care Verification**

Recognition for delivering the highest level of comprehensive care for expectant mothers and newborns

The Joint Commission's Maternal Levels of Care (MLC) Verification program, offered in collaboration with the American College of Obstetricians and Gynecologists (ACOG), has named Saint Peter's University Hospital as a Level IV maternal care verified facility. Saint Peter's is the first in New Jersey to receive this new prestigious designation – and the highest level to be achieved – from The Joint Commission.

The Joint Commission's Maternal Levels of Care Verification program provides an objective evaluation of a healthcare facility's capabilities. It verifies that a hospital has the expertise, equipment and resources in place for a patient's specific needs and risk level. As a Level IV facility, Saint Peter's


is recognized for its onsite medical and surgical care of the most complex maternal conditions and critically ill pregnant women and babies before, during and after pregnancy. Saint Peter's recently expanded the ability to view fetal heart rate monitoring for a mother—whether she's in labor and delivery or in the adult intensive care unit (ICU) by looking at one big monitor that's tracking all

the information for healthcare providers on all floors. This procedure increases situational awareness between healthcare providers, allowing them to monitor what's happening with each mother and baby on each unit.

"It is a tremendous honor to be the first hospital in New Jersey to receive The Joint Commission's Maternal Levels of Care Verification as a Level IV facility," said Carlos Benito,

MD, chair of the Department of Obstetrics and Gynecology at Saint Peter's University Hospital. "While Saint Peter's has long

been recognized regionally for its comprehensive care for expectant mothers and newborns, The Joint Commission's verification offers further validation that we are equipped to deliver all levels of care from low-risk to the most complicated cases."



Saint Peter's also earned The Joint Commission's Gold Seal of Approval® for Perinatal Care, a symbol of quality that reflects the organization's commitment to providing safe and quality patient care for mothers and infants leading up to, during and after birth. Saint Peter's has a statedesignated Regional Perinatal Center that includes a nationally recognized Level IV NICU for premature or fragile newborns who need specialty care. The NICU team has earned the Beacon Award for Excellence from the American Association of Critical-Care Nurses for three consecutive terms.

For women who are experiencing a low-risk pregnancy and looking for an alternative birthing experience, Saint Peter's opened the Mary V. O'Shea Birth Center in 2019 - New Jersey's first midwifery-led birth center to be located on the grounds of a hospital and accredited by the Commission for the Accreditation of Birth Centers. The midwifery model of care embraces pregnancy

and birth as a normal physiologic process, highlighting shared decisionmaking, minimal interventions, and the empowerment of women as partners in their care.

### **Maternal Levels of Care**

Level IV status includes verification for meeting the criteria required for Level I which is defined as "basic care" - caring for low- to moderate-risk pregnancies, demonstrating the ability to detect, stabilize, and initiate management of unanticipated maternal-fetal or neonatal problems that occur during antepartum, intrapartum, or postpartum period until the patient can be transferred to a facility at which the specialty maternal care is available, such as Saint Peter's. Level II is assessed as a hospital's ability to offer "specialty care," which includes meeting Level I criteria plus moderate- to high-risk antepartum, intrapartum, and postpartum conditions. Level III is assessed as offering "subspecialty care," meaning that in addition to meeting the criteria for Levels I and II, the facility must show the ability to care for more complex maternal medical conditions, obstetric complications and fetal conditions.

Saint Peter's underwent a comprehensive two-day on-site review by a Joint Commission surveyor to verify the level of care provided. In addition to speaking directly with patients and tracking them through all phases of care, the surveyor interviewed staff; assessed Saint Peter's performance improvement plan; reviewed staff education; and completed a full review of the hospital's credentialing/privileging process related to maternal health care. Unit tours included observation and inspection of every stage of care and interaction, from admission to labor and delivery, as well as to the neonatal intensive care unit (NICU). The assessment also included oversight of processes related to patient education and staff communication.

"The Joint Commission commends Saint Peter's University Hospital for being named a Level IV maternal care verified facility and for its efforts to standardize maternal care and reduce maternal morbidity and mortality," says Mark Pelletier, RN, MS, chief operating officer, Accreditation and Certification Operations, and chief nursing executive, The Joint Commission. "The Maternal Levels of Care Verification program will help Saint Peter's strengthen regionalized care for mothers and babies in its community."

The annual Procedures & Conditions ratings are designed to assist patients and their doctors in making informed decisions about where to receive care for challenging health conditions or elective procedures. These ratings extend the *U.S. News* mission of providing consumers with patient decision support beyond the Best Hospitals rankings, which are geared toward complex specialty care.

For the 2022-2023 Best Hospitals rankings and ratings, U.S. News evaluated more than 4,500 hospitals across 15 specialties and 20 procedures and conditions. Fewer than half of all hospitals received any High Performing rating.


